In an effort to create a talented pool of teachers for Liberal for the foreseeable future, Seward County Community College has entered into a partnership program, K-STEP UP, that will allow our graduates to earn a bachelor's degree in education from while living at home.

Working with the K-State College of Education and USD 480, SCCC will serve as the important conduit of higher education offering general education courses and a dedicated academic advisor. These credits will transfer to K-State, where students will then take education courses online. Students will complete their student teaching experience in our local schools and be supervised by a teacher mentor.

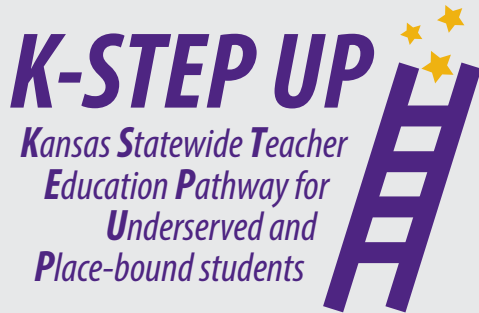
