- The fall 2021 tuition rate is \$1722.60* for a 3-credit-hour graduate course. Out-ofpocket expense is reduced by the branch of service tuition assistance (TA).



- Admission process includes the completion of an application form, the provision of a written statement of objectives and submission of official transcripts of the last 60 hours of undergraduate coursework.
- If individuals want to complete both degrees (CGSC – MOS & K-State MS in Adult Learning and Leadership), we can only accept 6 credit hours for transfer to the MS degree. There are online courses that students can take during the summer prior to starting CGSC or at the conclusion to complete the credits necessary for the MS degree.
- Class times are 5:30–9:30 p.m. on Tuesdays and Thursdays.
- Textbook lists will be distributed prior to the first course. Students will need to secure their textbooks prior to each class start date.
